Minutes:

The Minutes from the General Meeting on Aug 26, 2025 were approved unanimously.

Treasurer's Reports:

The Club has a balance of about \$30,000. We have a surplus of \$9,000 from last year's budget. Some big ticket expenses (pickleballs) are coming up. We expect to be around \$26,000 by End of Year. Our CDs earned \$452 of interest income this year. We will find out if any (all?!) of our HOA proposed project are approved by end of November. First Interstate (our current bank) was purchased, so we will be dealing with a new bank. Unfortunately, the new bank will not offer Zelle for membership dues. However, Court Reserve will offer an on-line payment option. As of Oct 1, we have 674 members with the expectation that we will be back over 700 by year end.

The Treasurer's Reports from August and September were approved unanimously.

Draft Budget for Fiscal Year 2026:

The draft budget was presented and explained. A copy is attached. An email to vote for approval/non-approval of the budget will be sent out to the membership prior to the November 21 General Meeting.

Survey Results:

A presentation was made about the responses to different play styles broken down by rated skill level. A link to the presentation charts is attached. Feedback from the survey was used to develop the schedule going into effect on Monday.

AED Training:

The Board reached out to Lois to schedule more training dates. If she is unable to facilitate, there is a training room at the Fire Department (located near Dollar General in Eloy) that can be used. More information to come.

Court Reserve:

Members received an email with an explanation of how to log in. It also came with tutorial videos. Two orientation classes have been held and another class is scheduled for Oct 24 at 3:00 in the Cheyenne Room. An Ambassador List has been established. They are a list of people who can answer questions. Additionally, a FAQ section for our club was written and posted on the Court Reserve site. Monday, Oct 13, is the official roll-out date. The Fitness Center will no longer post a daily schedule because unlike Hold My Court, Court Reserve is fluid (reservations and cancellations can be made day of).

Don't Fall Festival:

The party will take place Friday, November 7, 12-4pm at the courts. Tickets go on sale Monday (Oct 13). Dates and times of ticket sales were sent out previously. The price to attend is \$5 and includes a sandwich of choice (burger, brat, hotdog), chips, drink, and entertainment. There will be different fun games. Dancing begins at 2:00. Bring a chair.

Rating Season:

Our rating season has begun. We have more than 30 people already signed up. The first testing round robin is next week.
